BEYOND THE BELL PROVIDES A SUPPLY OF NEW SCHOOL CLOTHING TO SCHOOLS; THE STUDENTS RECEIVING THESE CLOTHES ARE NOT OTHERWISE SERVED BY OPERATION SCHOOL BELL.
