IN THIS 35TH YEAR OF CONSECUTIVE OPERATION, THIS PROGRAM REACHED 3,376 CHILDREN WITH NEW CLOTHES AND SUPPLIES, AND 2,850 STUDENTS WITH NEW SHOES. BEYOND THE BELL PROVIDES A SUPPLY OF NEW SCHOOL CLOTHING TO SCHOOLS; THE STUDENTS RECEIVING THESE CLOTHES ARE NOT OTHERWISE SERVED BY OPERATION SCHOOL BELL.
